OPTIONAL EXCURSION (Not Included with Tour) - If you would rather take the train to Silverton (3 ½ hours) and back or motor coach bus back (1 ½ hours) instead of traveling in your Corvette, you can make a reservation with the Durango & Silverton Narrow Gauge Railroad by calling 1-888-TRAIN-07 or visiting www.durangotrain.com. We recommend the open-air gondola for the best view. Sunglasses and dark clothing are recommended due to the soot that can fly through the air. You should also dress in layers due to the cool, morning temperatures and elevation change up to Silverton. It is a little more expensive to take the motor coach bus back from Silverton, but we recommend it. Taking the train both directions can make for a long day. You might want to also consider booking deluxe class for the train ride. These upgraded cars (such as the Rio Grande) offer larger, more comfortable seats. Some adults feel the seats in the standard class are too small.

Cancellation of Tour Corvette’N America reserves the right to cancel this tour at any time. If this tour is cancelled, we will first attempt to re-book you on another tour if you choose, subject to availability. However, if we are unable to re-book you or you wish not to be re-booked, a full refund will be issued to you.

No Refund Policy By attending this tour, I understand and agree if I am unable to complete a tour once a tour is in progress, due to physical or mechanical problems (including but not limited to my car breaking down), no refund will be paid to me or my guest by Corvette’N America.

****LIMITATION OF LIABILITY****

In consideration of Corvette’N America, L.L.C., d/b/a **CORVETTE’N AMERICA TOURS** (hereinafter “Corvette’N”) allowing me to participate in the Grand Canyon/Rocky Mtn. Tour (the “Tour”) on June 20 - 25, 2018, I hereby agree to this Limitation of Liability Agreement (“Agreement”).

I am aware, understand, and accept the fact that my participation in the Tour may entail both known and unanticipated risks. I acknowledge that such risks cannot be eliminated without jeopardizing the essential qualities of the Tour. Risks associated with the Tour include, **but are not limited to:** automobile accidents; automotive theft; hazards of walking on uneven terrain and slips and falls; becoming injured or lost; negligence of other persons or animals (including, without limitation, dogs); the condition, operation and hazards associated with roads, highways, trails, vehicles, or other means of conveyance; the forces of nature, including wind, rain, lightning and rapid weather changes; the risks of falling; the risks inherent in driving; the risks of exposure to insect bites; the risks of cold, including hypothermia; food poisoning; and the physical exertion associated with participating in the Tour.

I understand that any of the above risks, dangers and hazards could result in personal injury, sickness, death, or personal property loss or damage.

In the event that Corvette’N is found to be liable to any extent, or for any reason, I expressly agree that the liability of Corvette’N, its agents and employees, and to all persons having contractual relationships with them, in connection with services provided hereunder to me, resulting from any negligent acts, errors and/or omissions of Corvette’N, its agents and/or employees is **limited to the total fees actually paid by me to Corvette’N** for services rendered by Corvette’N in association with this Agreement.

I have read and understood the terms of this Agreement. I am signing it freely and of my own accord, and understand that it is binding upon myself, my heirs and assigns. If a minor will be on the Tour, I certify and warrant that I am that minor’s legal parent or guardian, and that I have full authority to execute this Agreement on that minor’s behalf. I understand and agree that this Agreement is governed by the laws of the State of Arizona. As a condition of being allowed to participate in the Tour, I agree to all terms of this Agreement.
